- Project coordination to reduce effects on species






The problem with Science and Scientists

The Revival


- Career Coaching session

Moving Forward

- First thing I needed: HELP!
- I recruited a coworker with similar experience
- To do list
 - List all agencies we needed
 - Find all contacts for those Biologists
 - Draft intro email
 - Name our group



Potential Problems

- Talking to Biologists about changing their work can be risky...
- Starting an interagency group can be like herding cats
- I still need to manage my regular workload
- Time is short to get this group started!

Response

- Initial project proposal went out to 4 agencies, federal, state, and NGO
- ALL 4 agencies have responded (all were positive!)
- Lots of intrigue
- A little skepticism
- Lots of positive attitudes!

Ready, Set, GO!







- All of a sudden, it was MAY!
- Many systems stop sampling in May or June and we had to try to schedule 13 trap visits in 4-8 weeks!
- Scheduling... well, was like herding cats
- Adaptations were made
- Visits were scheduled!

Phase 1 is a go

- So, the site visits are happening currently
- I have officially started an interagency effort
- I have taken the lead on a project of my own making for my agency
- Now, to keep the steam going!
